Bill Lindsley – related his background – why he is running as a write in, related his disappointment with the commission and city council over SFS issue, He also feels outlying communities are short changed & commission lacks long term planning, The meeting was open up to a Q & A Make sure you write in Bill Lindsley AND fill in the mark in the oval Between now and election day –

Bill again said only to access voter lists.

Jack Howard – presented his thoughts about what help he needs. His concerns were coordination of campaigns. Glen reviewed with Jack what we have offered.

Glen summed up by asking Jack specifically what he wanted from UCD. Jack's request was to use the voter file. Glen will work with Valerie for Jack as well.
