Opportunity to make some progress to execute,

Jack – to succeed, step away from state and Federal politics, make connections, need candidate to engage folks, respond to candidate, groom local candidates well ahead of time, need cross over votes, get our message out about advocates for middle class, open government that belongs to people,

Item: Thoughts & vision of UCD

We succeeded in electing a new commissioner & passing school bond, good opportunity to elect fresh candidates, passing the non partisan commissioner,



RN: nationally 35% of electorate voted, 15% elected the outcomes we got, many people say it doesn't make a decision, expect as a Dem party to mobilize & enthuse the community we will have to influence the populace, promote issues that are of interest to the community

Disenfranchise voters – all politics is local Engaging voters...

Precinct one has 3 vacancies, Norm & Rebecca are currently PCPs, we've got lots of slots,

Vote taken, Jack & Bill appointed

Carole nominated as chair by Glen seconded by Mary

Vice Chair responsibilities: be at meeting and assume & take



over as chair in her absence, quarterly meetings at state level chair is a delegate, alternate delegates can be appointed, Glen has attended about 4 times in 4 years, can be spendy, telephone conference meeting with chair & vice chair, occasionally quarterly meeting was '08 (?) vice chair is not

Bill Lindsley nominated as vice chair by Kathleen, Bill Lindsley is elected vice chair

Treasurer, working with assumption that Janet Hume will continue if she declines we will bring up at a future meeting Glen nominates Janet, second by Kathleen, Carole will contact Janet

Secretary – need a nomination will Sharon continue until candidate can be found, agreed to serve until she moves, further arm twisting to find a replacement

Continue to look for others who want to be a part of the leadership of UCD

State rules have a gender balance stipulation

Alternate candidate to state, Glen volunteers,
