Side conversation: Wolf issue will likely be coming, being discussed at State level & Marian County. We may be should be preparing a statement as Union County's voice rural caucus.

Item: Report on US uncut Demonstrations 4/15

• Small group came together at Max Square, (but we outnumbered the Tea Party spite their half page ad and IPOD give away. Does Walden have open meetings? Mary can find out when his schedule, was here last month at Flying J, get it through Chamber, it was open to the public as a Chamber event, lots of voices to shut the government down, debt is more transparent with Obama because wars have been added into the budget, some discussion of EPA and government
